MARMARA UNIVERSITY JOURNAL OF ECONOMIC AND ADMINISTRATIVE SCIENCES GUIDELINES FOR ARTICLE SUBMISSION¹

1. Article Submission

- Three print-out copies the of article and one CD including the article in MS Word format will be posted to the mailing address of the Journal of E.A.S. Articles submitted via e-mail will not be admissible.

2. Article: General Requirements

- Title will be center-aligned.
- Authors' name and surname will be written under the main title, right-aligned.
- Sign (*) can be put after the name of the author in order to point out address and e-mail information belonging to the author at the bottom of the page with the title.
- Title and author's name will be followed by an Abstract that briefly mentions aim of the paper, methodology used and general considerations of the study with 50 to 300 words. Keywords for the paper will be written below the Abstract. And three-digit JEL Classification Codes² including the subject category of the article will be given under the Keywords. An article can belong to multiple JEL Classifications.
- Article will include an Introduction section. In this section, importance of that study is explained and a general assessment of related studies in the literature will be stated in general.
- It is expected that the articles submitted to the journal will not exceed 25 pages.

3. Sections

- Sections will be divided into Headings and Sub-headings according to their contents and will be organized according to decimal numbering scheme.
- In the sections following Introduction, theoretical and/or empirical foundations of the study, methodology and data collection technique, after following a systematic order, will be assessed in general in the light of key findings obtained.
- Notes that are required to be expressed, but interrupts the flow of main statement or information that is explaining an issue in detail will be included in footnotes.
- Final judgment will be included in "Conclusion".
- Sources used in the article will be included in "References".
- All sections of the article will be numbered in bold and subsections will be indented.

- Footnote will be written at the bottom of the page.
- Sources will be cited in footnotes as in the following examples:

Footnote Examples:

Book: Footnote number, author's name and surname, title of the book (**BOLD**), edition number, city that book was published in, name of the publisher (if any), year that book was published, page numbers that are referred to.

In the studies written in Turkish, edition numbers of publications in foreign languages will be written in footnotes and references as it was included in the original reference (PAGE NUMBERS WILL BE EXCLUDED).

Reference to The Same Source for the Second Time: When referring to the same author for a second time in the article, short form of reference will be adequate (author's name, **ibid.**). If different page numbers of the source are referred to, page numbers will be added to citation (author's surname, **ibid.**, page numbers). When the author have multiple documents that are referred to in the article, short title will be included as (author's name, **short title, ibid.**, page numbers).

Publication Written by an Organization: Name of the organization, title of the publication (**BOLD**), city of publication, year of publication, page numbers that are referred to.

Journal Articles: Author's name and surname, title of the article (in quotation marks), title of the journal (**BOLD**), volume number, issue number or publication number, publication date (month and year) or publication period (months covered and year), page numbers that are referred to.

Publication Written by Two Authors: Authors' names and surnames in the same order of the list in the source, title of the publication (**BOLD**), city of publication, name of the organization that made that publication, publication number (if any), year of publication, page numbers that are referred to.

Publication Written by Three or More Authors: First author's name and surname on the list in the source, followed by expression "et al." (and others), title of the publication (**BOLD**), city of publication, name of the organization that made that publication, publication number (if any), year of publication, page numbers that are referred to.

W. Mendenhall et al., **Statistics for Management and Economics**, Sixth Edition, London, WPS-Kent Publishing Company, 1989, p. 54.

Academic Thesis: Author of the thesis, title of the thesis (in quotation marks), city that educational institution is located in, educational institution that thesis is approved by, date that thesis is approved, page numbers that are referred to, type of degree (MA or PhD Thesis).

Professional Publications and Scientific Reports: Name of the organization that prepared report (BOLD),

Interviews: Name and surname of the interviewee, interview date.

REFERENCES OR BIBLIOGRAPHY:

Author's surname (in capital letters), author's name and title of publication will be cited according to the same rules applicable to footnote citation. References will be listed in alphabetical order. Page numbers of the journal articles that are referred to will be included.

5. Tables, Graphs and Diagrams


Each table, graph and diagram in all sections or appendices will be numbered one by one. The number of each table, graph or diagram will be followed by its title. There will be half line spacing between the line that title is written and the figure below. If title is longer than a line, it will be written by using 1.0 line spacing. Source of figure that is referred to in the text will be given below the figure with no line spacing. Source of figure will be cited below the figure as "Source:....." . In general thinner border line is more appropriate (3/4 pt). Variable names given in the first row and column of a table or in the axes of a graph should be written in BOLD. Each table, graph or diagram should be located in the best possible distance to the comment mentioned in the text by referring to that figure.
