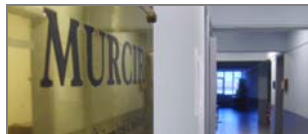

### **Understanding Violent Conflict: A Comparative Study of Tajikistan and Uzbekistan**



The factors cited in the literature on violent conflict in general and on the Tajikistan civil war in particular as the causes of violent conflict were present both in Uzbekistan and

Tajikistan, nevertheless only the latter experienced civil war. The fact that the same variables did not produce the same outcome presents an empirical puzzle. The study makes a balance of power argument. Unlike classical balance of power theories, this study argues that it is the even balance of power between adversaries which leads to war.

This study also analyzes the various factors which produce these balances. It argues that structure, process and network-related factors all influence the balance of power. Emerged under the influence of differently developed structure, process and network-related variables in both countries, balance of power between adversaries in Tajikistan led to war, whereas imbalance in Uzbekistan prevented eruption of similar violent conflict there.

### **Strategies for Combating Racism in Europe**



Assoc. Professor Gün Kut from Bogazici University talked on the institutional structure established by European Union in combating racism. Kut as a member of ECRI (European Commission Against Racism and Intolerance) representing Turkey, and former member of the European Monitoring Centre on Racism and Xenophobia (EUMC), which was replaced by Fundamental Rights Agency in 2007, shared his experience in this field with the audience. Prof. Kut devoted the first part of his speech to the institutional evolution in Europe regarding the new perspectives and policies developed for combating racism. In the second part of his speech, he analyzed the problem of racism in the context of Turkey and the differences between racism in European and Turkish cases.

##### **In the Shadow of the Palms - Iraq (March 28, 2008)**

Director: Wayne Coles-Janess

"In the Shadow of the Palms - Iraq" is the only documentary filmed in Iraq prior to during and after "liberation". The film documents the changes in Iraqi society and the lives of ordinary Iraqis by focusing on a cross-section individuals. With audiences skeptical of stereotypical and embedded reports, "In the Shadow of the Palms - Iraq" presents audiences with a window into the everyday realities for the diverse individuals living through this controversial war.

#### Wednesday Talks (cont'd.)

Based on her own research, publications and forthcoming publications, Nur Bilge Criss chronologically highlighted the nature of relations since World War I; between the interwar periods, mutual diplomatic reciprocity by 1937 when a U.S. ambassador took up full time residence in Ankara. Discussion centered around the American military presence in Turkey and cultivation of dependency on the U.S.A., which culminated in the deployment of IRBMs (Jupiters) in Turkey, an extremely risky venture in the late 1950s. Reasons for this decision-making were explored on Turkey's part as well as the spillover effects of the Cuban missile crisis of 1962 on the relations.



A survey of political/diplomatic issues such as the Cyprus crises, Soviet approaches to the Cyprus issue, the U.S. arms embargo (1975-1978) on Turkey and its aftermath were discussed.

Discussion stretched to the crisis right before the 2003 Iraqi war in bilateral relations, when Turkey's then prospective prime minister promised the U.S. President that between 60,000-80,000 American soldiers could be deployed in Turkey for an incursion into Iraq from the north. Turkey's prime minister ended up misleading the U.S. because the Parliament voted down the resolution for deployment. This diplomatic scandal damaged the relations for some time to come.

##### **Compulsory Labor Regime in the Zonguldak Coal Field: The RPP Paternalism and Petitions of the Zonguldak People, 1940-1947**



The Second World War marks a specific sub-period of history for the Zonguldak coalfield. The nationalization of coal mining under state full ownership and the establishment of the compulsory labor regime and Soil Product Tax intensified coercive presence of the state in each and every part of daily life in the basin. The compulsory labor was one of the most coercive instruments by means of which the state disciplined the mine labor and ensured an adequate labor supply to the coal pits. The strategic importance of coal in wartime compelled the state to impose compulsory rotational labor in the mines, based largely on men residing in villages of Zonguldak province. This practice resulted in endangerment of the agriculture-based subsistence economy of the villagers and increased the burden on women and children as well.

Along side coercive practices, the state appealed to practices aiming at creating consent among the people of the basin. The Republican People's Party established an intense communication

The documentary film tells the story of Circassians forced to emigrate in 1864 after the long wars resulted from the Russian invasion of North Caucasia. Inhabiting different locations in Anatolia, the second, third and fourth generations of Circassians tell the stories of the migration, how they built their new lives and their traditions that make Circassians exceptional. The documentary depicts them in their daily lives and their rituals, both in Turkish and in their own language which is an inseparable part of their culture.

In 1968, preparations were under way to build the first bridge in Istanbul, "the biggest village." A group of university students opposed the building of a bridge in Istanbul demanding that the eastern and western parts of the country receive equal investment opportunities. With a national campaign that they initiated, a suspension bridge was built on Zap River, which was named the "Revolutionary Youth Bridge".

**Reflexion of Greco-Italian War of 1940 in the Turkish Press, *Tasviri Efkâr* and *Tan***



Zuhal Mert presented her M.A. thesis she has written at Democritus University of Thrace, Greece. Her study analyses the reactions of Turkish public opinion to 1940 Greco-Italian war in two Turkish newspapers, *Tasviri Efkâr* (of Velid Ebuzziya) and *Tan* (of Zekeriya Sertel), which are from different ideological backgrounds.

Some interesting examples from writings of the prominent journalists on these newspapers are interpreted with reference to dominant international system of war and domestic atmosphere of Turkey towards the year 1940.

In addition, visual materials, such as caricatures and photographs, are examined in reference to historical accumulation of Turkish intellectual memory. Unanimous empathy with Greeks that is created by Turkish journalists and opinion leaders is presented in detail.

#### International Conference on "Political Representation and Participation of Minorities in the Balkan Democratization Process", Sofia

November 30 - December 1, 2007



The international conference on "Political Representation and Participation of Minorities in the Balkan Democratization Process" organized in collaboration with New Bulgarian University (NBU) under the sponsorship of Turkish International Cooperation and Development Agency (TIKA) was held in Sophia on November 30 - December 1, 2007.

The two-day conference was composed of four sessions where the participants from Bulgaria and Turkey presented their papers. Regarding the framework of the conference, the topic whether legal equality is enough for minorities was discussed. The main concluding remarks were that the concepts of political participation and representation should be re-examined, the "politics of identity" and the "politics of idea" should be differentiated, and the local democracies should be strengthened for the improvement of the political representation and participation of minorities.
